PRODIGY PREP RULES AND POLICIES

I hereby agree to follow these rules, which are my responsibility to adhere to in order successfully matriculate through Prodigy Preparatory School For Boys. Place your initials in the space provided next to the rule signifying that you have read, understand, and will abide by the following rules.

DISCIPLINARY CONTRACT

1. ___ You may **NOT** leave the building or school grounds unless you have permission from an administrator and parents.
2. ___ This is a smoke free campus. You may **NOT** smoke/vape on school grounds.
3. ___ Remember, you are **NOT** to touch another student's property.
4. ___ All cell phones must be **TURNED OFF** before entering the building. **NO** text messaging allowed. **NO** sharing of cell phones will be allowed. The use of cell phones is a disruption of the educational process and will **NOT** be tolerated.
5. ___ **NO** headphones, iPods, or any other music devices are allowed during school hours.
6. ___ Students having 10 or more unexcused absences will be identified as truant.
7. ___ Students are expected to obey their teachers, as well as other school employees.
8. ___ You may **NOT** disturb the class or school by being disrespectful or rude, refusing to obey any staff member, failing to follow classroom rules, throwing objects, or possessing any weapons.
9. ___ You may **NOT** possess and/or distribute materials prohibited by law including, but not limited to, pornographic/obscene material.
10. ___ You may **NOT** misrepresent yourself by cheating, copying, plagiarizing, counterfeiting, and/or using false identification.
